



Visual Harvest – 2018

A Juried Art Exhibition

Presented by the Gaston County Art Guild at Arts on Main
September 8, 2018 – November 14, 2018

Eligibility

All artists 18 years and older living in North Carolina & South Carolina may submit up to two entries upon the payment of a non-refundable entry fee. (Guild members, \$30; non-members, \$40. Additional entries will be \$5 per entry for members and \$10 per additional entry per non-members.) **All entries MUST BE hand delivered.**

Photography, painting, drawing, sculpture, glass, ceramic, jewelry, printmaking and fiber are eligible. All work must be original, completed within the last 2 years, and NOT previously exhibited at a Gaston County Art Guild show. No stock or published images may be used as a source. The juror will select the art to be exhibited and choose the awards. Artists will be notified of acceptance of their work.

All entries MUST BE hand delivered.

Specifications

Up to two works from each artist may be submitted. These may be two or three dimensional works and must have been completed within the last two years. Watercolors, pastels, drawings and prints must be protected by glass or Plexiglas and framed. All two dimensional work must be appropriately wired for hanging. **(no saw tooth hangers)** Maximum size for two dimensional work can be **no larger** than 60" in any dimension. Maximum weight for sculpture is 200 lbs. Entries must be available for purchase and hang for the duration of the exhibit. The Guild will retain a 30% commission on member's sales and 40% commission on non-member's sales, other than purchase awards.

The Guild will decline any work that does not meet their standards & specifications.

The attached entry form must be completed and entries identified by artist name, title of work, medium and price.

Checklist for Entries

- Entry fee of \$30 for GCAG members. Must be member in good standing. \$40 for non-members. Entry fees are non-refundable.
- Entry fee of \$10 for student GCAG members age 18 and above
- Identification form and inventory slip clearly printed or typed
- Identification affixed to the back of work

LIABILITY:

Entries will be treated with care, but each individual artist retains liability for his/her work.

AWARDS:

Awards will be presented by the Gaston County Art Guild with the amount determined at a later date.

SALES:

The Art Guild will receive a 30% commission on member's sales and 40% on non-members. All sales will be handled at the gift shop at Arts on Main at the end of the show.
